# 2011 FOCUS New Jersey: Call for Artists

## Eligibility:

Any artist currently residing in New Jersey may submit up to two entries for jurying.

## Entry requirements:

- All work must be original. - No kits or copies or giclée prints. (Mounting, matting and framing excluded)
- Artwork must be **no more than 38" and no less than 11"** in any dimension **including** matting and frame.
- Sculpture **may not exceed 20"** in any dimension; **measurements must include the base.**
- **All work must be ready to hang with screw eyes and wire, labeled at the back** (or at the bottom if 3-D).
- Where necessary, artwork should be protected with Plexiglass only.
- If the work is incorrectly categorized, it will be moved to the correct category if possible or taken out of competition at the discretion of the jurors.
- While every attempt will be made to preserve, secure each entry submitted, the sponsoring organizations will not assume responsibility for loss or damages incurred. Entry in the exhibition signifies compliance with this waiver.
- No artwork may be removed prior to the close of the exhibition.
- All artists **must** submit entry forms by **Oct 14, 2011**.
- Please send Self Addressed Stamped Envelope for CD returns.

## Categories:

- **Acrylics**
- **Oil**
- **Pastel** – pastel, chalk, charcoal, oil pastel
- **Watercolor** – inc. gouache
- **Drawing** – pencil, pen, ink, graphite, markers
- **Mixed media** – including collage (entry must specify media); combines two or more media, no one of which clearly predominates (inc. collage and assemblage)
- **Photography** – includes any image created using a light-capturing device such as a film-based or digital camera, scanner, pinhole camera, etc., in any part of the process.  
*Please note* : This includes color, black & white or tinted photos, digitally manipulated photos, photograms, etc.
- **Computer Imagery** – artwork created by computer **only**, using a pixel-based painting or graphics program, such as Adobe Photoshop, Adobe Illustrator or Corel Painter etc.  
*Please note* : Photos taken by digital camera, digitally-altered photos and images made using a scanner must be entered in the *Photography* category.
- **Printmaking** – inc. etching, engraving, dry point, intaglio, lithograph, woodcut, monotypes, silkscreen, etc.
- **Sculpture** – any work designed in 3-dimensions, carved or constructed in any medium, abstract or figurative, painted or unpainted. (No more than 20" in any dimension including base.)
